PAYMENTS & GUEST FEES

Memberships and court fees are automatically billed monthly via the selected payment type as specified on your registration form. Membership fees are automatically billed annually (or via the payment plan below) according to your chosen payment method, as specified on your registration form. Account charges (including food & beverages and court fees) are processed on the 10th of every month. All memberships will automatically renew on an annual basis beginning January 1st, 2024. Can I pay each time at the desk or is everything on account?

Payments will be placed on your membership account, and you will receive a receipt alongside a monthly statement.

Can I cancel my membership at any time?

Memberships can be cancelled at any time with a minimum of 30 days' notice. If you cancel your membership, you will not be eligible to rejoin (or join the waitlist) until a full year from your resignation date. There will be no refunds/credits for all payments that have been processed.

Holds: We do not offer any holds including medical leaves.

What payment types do you offer? Do these have additional fees?

Membership Fees: PAP (no additional fee) or credit card (will incur a 3% additional fee). Monthly house account charges: PAP (no additional fee) or credit card (no additional fee).

I am a current Greenhills Golf Member, are there any discounts for me to join tennis?

If you are an existing Greenhills golf member, you will receive a \$400 discount on your tennis membership. No holds permitted. This discount will only be applied to memberships paid in full.

BOOKING

Rules, regulations, member policies and procedures will be accessible via the member's portal. Once you are registered as a member, we will send out logins and information for our booking system, Salix. You will have access to booking your courts 7-14 days in advance.

GUEST FEES

Guest Fees: \$32+HST/visit – Includes the Court Fee

*All guests must be with an active member.

A single guest is permitted a maximum of 5 times/calendar year.

BOOKING CANCELLATION

Beginning January 1st, 2024, all cancellations require 24 hour notice, any cancellations and/or no shows within the 24 hour period will be charged a fee. All players/guests listed on the booking will be charged to the booking member's account.

What is a Food & Beverage Minimum?

A food & beverage minimum is a specific dollar amount of food and beverage that you must spend by the end of the current year.

What happens if I don't spend it by the end of the year?

If you do not spend the minimum amount by the end of the current year, the remaining amount is then charged to your account via your preferred payment choice.

How do I use it?

- Purchase any food & beverage
- Participate in food & beverage events i.e. Prime Rib Night, Brunches, Christmas Events etc.

What doesn't apply:

- Pro shop merchandise
- Clinic/lesson/court fees & membership fees
- Cash payments for items will not be applied to your minimum.

Note: Taxes & Gratuities do not count towards your minimum.

Once a Food & Beverage purchase has been made on your membership account number, your minimum total will be reduced and visible on your next statement.
